KY Real Estate Appraisers Board - On March 25, 2020, Governor Beshear issued Executive Order 2020-257 requiring the closure of all businesses that are not 'life sustaining' to in-person traffic. Click here for the FAQ memorandum regarding this Executive Order for those licensees holding licenses from the Kentucky Real Estate Authority (Realtors, Auctioneers, Home Inspectors, and Appraisers).

On April 24, 2020, KREAB announced the following updates to the 2020 license renewal procedure due to the Covid-19 pandemic:

- 1. Continuing Education completion has been extended to June 30, 2020. With this extension, all education and renewals are now due by June 30, 2020.
- 2. The \$200 education late fee has waived. Renewals completed after July 1, 2020 will still be assessed the late fee.

Online renewal began May 1. 2020. <u>Renewals cannot be processed until education has been completed and submitted to the KREAB.</u>

**If you have already completed the 14 hours or will have the hours completed by the original deadline of May 31, 2020; all courses you complete after June 1 will apply toward the 2021 renewal.

**If you chose to use the extension and complete education after the original May 31, 2020 deadline, the courses you complete after May 31, 2020 will only apply toward the 2020 renewal. Additional education will be required for the 2021 renewal.

- Education Completion/Submission Date
 All Kentucky Certified, Licensed, Associate and Reciprocal appraisers must complete and submit to the Board fourteen (14) hours of continuing education. The education <u>must be</u> <u>completed</u> between the dates of May 16, 2019 <u>June 30, 2020</u>.
- Of the fourteen (14) hours of continuing education requirement, seven (7) hours must be the **2020- 21** National USPAP Update course.
- <u>Appraisers must</u> submit certificates of completion to the Board. The certificates can be emailed to <u>Angie.Thomas@ky.gov</u> or faxed to (859) 623-2598.

The Appraisal Foundation – The Appraisal Foundation's Qualifications Board (AQB) and PSI Services LLC announced the National Job Analysis Study of Real Estate Appraisal Professionals. The purpose of the job analysis is to identify tasks and competencies reflective of the real estate appraiser job role. The results will be used to update the Licensed Residential, Certified Residential, and Certified General examinations across the U.S. to help ensure real estate appraisal professionals meet acceptable standards for competent practice.

There are THREE parts of the survey. In Part I, you will be asked to provide background information. In Part II, you will be asked to review a list of professional activities (tasks) and indicate how often you perform the tasks and how important they are for your work. In Part III, you will be asked to review a list of knowledge areas and indicate how often you apply that knowledge and how important that knowledge is to your work.

The survey will take approximately 30 to 60 minutes to complete. You do not have to complete the survey in one sitting. You may exit the survey and return to complete it at a later time. However, *you must start and finish the survey from the same device*.

Appraisers may receive the survey from multiple entities (PSI, your state board, and the AQB). All of these survey invitations are for the same job analysis study. **Please only participate in the survey once!** When you have completed the survey once you can ignore other invitations and reminders.
