Special Zoom Meeting 45-Day Notice Discussion

Dec. 14, 2020 @ 4:00pm ET (3:00pm CT)

(approximately 30-45 minutes)

As you know, the attached 45-Day Notice was published and distributed to Appraisal Institute Professionals on November 16. The purpose of the 45-Day Notice is to present proposed Bylaws amendments to the Vice President election process as recommended by the Vice President Election Process Project Team (VPEPPT).

The deadline to submit comments regarding the proposed changes is December 31, 2020. The National Board of Directors will likely meet in early January to discuss and vote on the changes.

Region V will be hosting an informational meeting ((session) wherein the 45-Day Notice will be presented, and the floor will then be open for comments and discussion. No votes will be taken, and all Appraisal Institute members in Region V are welcome to participate. Attached below is a summary of the 45-Day Notice that will be presented at the meeting.

The Appraisal Foundation and Appraisal Institute Hold First Joint Valuation Symposium on Public Trust, Fair and Affordable Housing

The Appraisal Foundation and Appraisal Institute this week held their first joint valuation symposium on Promoting Trust for Fair and Affordable Housing. This free symposium featured thought leaders across the appraisal profession, mortgage lending, and academia in a discussion on fair and affordable housing issues and how to continue to uphold the public's trust in the appraisal process.

"Much like in the 1980's following the Savings and Loan Crisis, when appraisers came together to find solutions and create a common set of uniform standards and qualification criteria, the profession is now tackling a different crisis amid allegations of discriminatory practices," said The Appraisal Foundation President Dave Bunton during his opening remarks. "Once again, the issues our profession faces have the attention of members of Congress and the in-coming administration. It is time for appraisers to come together to look at the issue and develop meaningful solutions. This week's symposium was a first step."

"I want to acknowledge the important work appraisers do. We are one of just a few professions whose work is so closely associated with the American dream of home ownership and economic opportunity for so many in our communities. And it is those same neighbors who count on us to do everything we can to ensure our profession is free from potential bias or discrimination," Appraisal Institute President Jefferson L. Sherman, MAI, AI-GRS, said during his opening remarks.
